ENLISTMENT in the Military Forces entails various obligations under the Defence Act and these obligations continue, unless the soldier is sooner lawfully discharged, dismissed, or removed, until the expiration of his/her engagement.

2. OBLIGATION under the Defence Act (DA) 50, you are obliged to render specified periods of military service each training year until expiration of your engagement unless you are sooner discharged, dismissed, or removed from the ARes. The period of service you are required to render to be qualified efficient is:

14 days continuous training and 12 days obligatory training each training year.

3. LEAVE — Notwithstanding the above requirements you may be granted leave from home training activities on application to you orderly room. The conditions under which leave is granted will be advised to you at the time of your application.

4. EFFICIENCY — ARES — Under the provisions of Australian Military Regulations (AMR) 503, 504 and 505, members are classified as "efficient" each training year. Members classified as non-efficient may be discharged from the ARes. To be classified as efficient you must:

- a. complete the period of service stated above;
- b. attend Small Arms training; and
- c. perform satisfactory service.

5. PAY — The normal period of training for which you will receive pay is 26 days. You may be authorised additional training with pay.

6. DRESS Uniform and equipment is to be worn on all parades. Details of Orders of Dress to be worn will be promulgated on Unit Notice Boards. It is an offence under AMR & O 1332 to wear uniform or part thereof other than when travelling to and from and attending parades without Commanding Officer prior approval.

7. PERSONAL ISSUES OF UNIFORM OR EQUIPMENT . All members are responsible for the care, maintenance and security of all uniform or unit equipment on issue for the purpose of military training. Equipment is to be maintained at a high standard

at all times. Members are to ensure all equipment is secure at all times when in training and when out in training.

8. DAMAGE OR LOSS OF PERSONAL OR UNIT EQUIPMENT

Loss or damage to uniform or equipment caused by a member through neglect or unfair wear and tear is to be paid for by the member.

9. DISCHARGE Members finding it impossible to attend parades as required by 2 above are to make application for discharge/transfer to the Commanding Officer. Full reasons must be given.

10. DELIVERING UP EQUIPMENT - If discharge is approved, the member will be required to return all articles of equipment, uniforms, books etc. on personal issue and obtain a Unit receipt for such items. Failure to deliver up equipment, clothing, etc. when required to do so renders a member liable to prosecution under the Defence Act.

11. PROLONGED LEAVE - When leave of more than two months duration has been granted articles on issue to the member are to be returned to the Unit Stores where they will be held until the member returns to duty.

12. ILLNESS OR INJURY - Sustained during training or when travelling to or from training activities is to be reported to unit headquarters. Compensation may depend upon prompt action.

13. PERSONAL OCCURRENCES - Any change in a member's private address, next-of-kin, marital status, etc. is to be reported to the unit headquarters within 7 days.
